The following changes, additions and clarifications are made to the General Conditions and Specifications for the above referenced project. **Number of pages 1**

Pre-Bid Conference

1. Review scope of work for the resurfacing project and the existing site conditions – all the existing asphalt is to be removed, taking care around the manhole cover and clean outs. The plan shows the area of new asphalt and centipede sod is to be placed in areas were the asphalt is not going back and any other area that is disturbed.
2. Reviewed Time of Completion (22 days) the project is scheduled for the upcoming intersession.
3. Reviewed the General Conditions and Supplementary General Conditions of the contract.
4. Contractor is to include a Miscellaneous Allowance of \$5,000.00 for in the Base Bid.
5. There is not a bond requirement on these projects.
6. Reviewed MBE Document requirement.
7. The Affidavit of Capital Improvement is included in the bid package.
8. There were not any cores done on this project but there is a lot of broken areas to review thickness.
9. The undercut is to be hauled off the site.
10. There is not any stripping in the project.
11. The Contractor is to remove the two cut off steel pipes and surrounding concrete.
