

INVITATION TO BID

Sealed proposals will be received **10:00 a.m. May 19, 2022**, in the Cumberland County Schools' Operations Center Plans Room, located at 810 Gillespie Street, Fayetteville, NC, at which time they will be publicly opened and read aloud for the **Asphalt Re-Surfacing for Douglas Byrd High School Student Parking Lot ($\pm 101,860$ sqft), Hope Mills Middle School Rear Parking Lot ($\pm 45,700$ sqft) and Westover High School Driveway ($\pm 43,088$ sqft).**

The Contractor shall remove the existing asphalt and undercut the areas to receive 4" of stone base and 2" of asphalt. The Contractors shall visit the sites on their own.

Single prime proposals only will be received for all construction work. The Owner encourages participation by minority businesses.

A **Mandatory Pre-Bid Conference** will be held at the CCS Operations Center. Contractors interested in bidding shall meet at **10:00 a.m. on May 6, 2022** in the Training Room of the CCS Operations Center, 810 Gillespie Street Fayetteville, North Carolina 28306 (910) 678-2609.

Complete Bid Documents **will be issued at the pre-bid conference** from Blane Hunt, Planning and Construction Coordinator, Cumberland County Schools, (678-2557).

Requirements for bidding this project are as follows:

1. Three references from previously satisfied commercial customers.
2. **Furnish NC License Number** (G.S. Chapter 87 establishes licensing requirements for general, plumbing, heating, electrical, and refrigeration contractors for construction projects costing \$30,000 or more).
3. Insurance - The Contractor shall provide, as required by law, insurance for his employees. The Cumberland County Schools assumes no liability for injuries or accidents related to the Contractual Agreement. The Contractor shall furnish a certificate to the Owner (Cumberland County Schools) as a Proof of Coverage. The Contractor shall maintain and pay the Insurance Coverage, which shall not be less than the following:
