

## INVITATION TO BIDDERS

Sealed proposals will be received until **10:00 AM, March 30<sup>th</sup> 2022** in the Cumberland County Schools 810 Gillespie St. Fayetteville 28306, at which time they will be publicly opened and read aloud for the **Rockfish Elementary School Re-Roofing. This is a recover system totaling approximately 15,000SF.**

A **Mandatory Pre-Bid conference** will be held at the site. Contractors interested in bidding shall meet **at 10:00AM on March 17, 2022 at the school site. School address is 5763 Rockfish Road, Hope Mills, NC 28348.**

Single prime bids will be accepted in accordance with G.S. 143-128. Complete Bid Documents will be issued at the Pre-bid Conference.

Requirements for bidding this project are as follows:

1. Three references from previously satisfied commercial customers.
2. Furnish NC License Number (G.S. Chapter 87 establishes licensing requirements for general contractors for construction projects costing \$30,000 or more).
3. All bidders & subcontractors shall hold the appropriate license as issued by the State of North Carolina to perform the work specified.
4. Insurance - The Contractor shall provide, as required by law, insurance for his employees. The Cumberland County Schools assumes no liability for injuries or accidents related to the Contractual Agreement. The Contractor shall furnish a certificate to the Owner (Cumberland County Schools) as a Proof of Coverage. The Contractor shall maintain and pay the Insurance Coverage, which shall not be less than the following:
5. Workman's Compensation Employees Liability: \$1,000,000.00
6. Bodily Injury: \$1,000,000 per occurrence/ \$2,000,000 aggregate
7. Property Damage: \$1,000,000 per occurrence/ \$2,000,000 aggregate
8. Owned/non-owned, and hired motor vehicle: \$1,000,000 per occurrence/ \$2,000,000 aggregate
9. Excess liability coverage of \$2,000,000
10. Cumberland County Board of Education shall be included as an additional insured on the policy.
11. Such coverage for completed operations must be maintained for at least 2 years following final acceptance of the work performed under the Contract.
12. Recruitment of minority business participation in accordance with G.S. 143-128.

Each bidder must deposit with his bid, a bid guarantee in the amount of 5% of the bid amount as security, in the form of certified check, cashier's check or bid bond executed by a surety company licensed by the State of North Carolina.

A Performance Bond and Payment Bond, each in the amount equal to 100% of the Contract Sum will be required to be furnished with the execution of the construction contract.

The Owner reserves the right to waive any informality or to reject any or all bids.

No Bidder may withdraw his bid within 30 days after the actual date of the opening thereof.
