



CCS RISE 2021! FAQs for Families

Question	Answer
<p>What are the dates of CCS RISE?</p>	<p>Component 1 (invitation only) consists of two sessions:</p> <ul style="list-style-type: none"> ● Session 1 is June 7 -24 (Monday - Thursday only); ● Session 2 is July 12-29 (Monday - Thursday only). <p>Component 2 is open for all K-12 students and is VIRTUAL:</p> <ul style="list-style-type: none"> ● July 12-29. ● Teachers will have office hours every Tuesday and Thursday.
<p>Why was my child invited to attend CCS RISE?</p>	<p>Elementary: Your child has been identified as 'at-risk' according to SuccessMaker or iStation data or is a possible retention candidate. Third Graders who have not met a Read to Achieve pathway are also invited to CCS RISE.</p> <p>Middle: Your child has been identified as 'at-risk' according to a variety of data points: EVAAS prediction, SuccessMaker, and/or Course Grades.</p> <p>High: Your child has been identified as either a student who has failed a course eligible for credit recovery, based on grades, could potentially fail a course eligible for credit recovery, or could potentially earn a CTE certification based on previous coursework. CCS RISE will offer high school students the opportunity to earn credit in select courses or potentially earn CTE certification by completing particular requirements.</p>
<p>I completed the intent form (declined), but now I want my child to attend.</p>	<p>Unfortunately, if you declined on the Student Intent Form, your child is unable to attend CCS RISE 2021! at this time, but you may complete the waitlist form on the district website.</p>

<p>How can I get my child into CCS RISE?</p>	<p>If your child did not receive an invitation on April 29th, they did not meet the criteria and are not eligible to attend Component 1.</p> <p>All K-12 students are invited to attend Component 2, which is a virtual only option from July 12-29 (Mon-Thur only).</p>
<p>Is CCS RISE mandatory?</p>	<p>No, but it is highly encouraged. Parents or guardians shall make the final decision regarding the student's attendance.</p>
<p>We are attending RISE and need devices and/or the internet. How do we get them?</p>	<p>Devices will be provided for students attending Component 1, virtual only. Device allocation will be determined based on information shared when you complete the intent form process. If you did not indicate your need at that time, please see the Site Based Administrator at your assigned site on Open House, June 3, 4-5 p.m.</p>
<p>Will my child fail if they do not attend?</p>	<p>No, but CCS RISE will give your child extra support in ELA, Math, and Science in order to review Priority Standards from this year.</p>
<p>Can my child be retained if they attend CCS RISE?</p>	<p>Kindergarten students who participate in the CCS RISE 2021! shall be exempt from retention for the 2021-2022 school year with a supplemental support plan developed for the student for first grade if needed. A Kindergarten student may only be absent 3 of the 24 summer learning days.</p>
<p>What location will my child be attending for CCS RISE?</p>	<p>Students accepted into the program either from the initial invitation in April or accepted from the Waitlist registration received a Confirmation Email notifying them of their acceptance to participate and their CCS RISE School assignment on May 26-28th. Encourage parents to check their child's ccs email to access this. We are sending a parent link call on May 27th to remind parents of these students to check their child's email to see their child's site assignment.</p>
<p>My child has a change in transportation for CCS RISE, who do I need to speak to or what do I need to do?</p>	<p>You will need to speak to the Site Based Administrator at your assigned site on June 3, 4-5 pm during Open House.</p>
